### Special Notes:

Online registration is preferred, but walk-ups are accepted for an additional fee of \$10 on the first day of camp. Cash or check is the only accepted form of payment for walk-ups. A parent or guardian may register their child in person on the first day of any camp that has not yet reached capacity. If the camp is at capacity, walk-ups will not be accepted. Walk-up registration does not guarantee a camp t-shirt or any additional camp items given at camp. Camp t-shirts and additional camp items must be ordered at least 10 days prior to the camp start date. For those registering within 10 days of the camp start date, camp t-shirts may not be available. Be sure to register early to ensure your child receives a camp t-shirt. If you need to cancel and refund your child's camp registration, please email the coach in charge of that camp with your order number, your child's name, and the camp your child is registered for. Any requests for camp refunds will be processed when the Athletics and Fine Arts offices reopen in mid-July. Any last-minute changes to the scheduled camp times or locations (i.e. due to inclement weather) will be communicated by the camp coach to those who have completed online registration. Please make sure to register using a current email address and phone number.
